11/096 – PARISH COUNCIL MATTERS

Allotments - The tenants about whom complaints had been received attended the meeting and Councillor June Collier explained to the tenants that concerns had been expressed by fellow allotment holders with regard to weeds on the plot, which at times seeded and caused issues for others and also that the plot was left untended at times. The tenants asked what the Council's standard of cultivation was and explained that obviously being in full-time employment their plot was not going to be maintained to the same high standards as others who are no longer in employment. They explained their plans for the forthcoming year and also that since taking on the plot improvements to it have been made each year with crop yields exceeding their expectations. The tenants also expressed their regret that those with concerns about their plot had failed to approach them regarding the above issues and had made formal complaints to the Parish Council. Councillor Richard Banbury expressed regret that the plot had not been cultivated prior to their occupation. The Council agreed that in future allotments holders who had an issue would be asked to take it up with the plot holder directly.
