### 3. West Oxfordshire Healthcare



– this has become a very important issue during my time as MP. The proposed closure of Deer Park is ongoing, and I have had further meetings with Oxfordshire Clinical Commissioning Group about this important issue. I have further met to with OCCG to discuss the future of Chipping Norton hospital, with the Hospital Action Group.

Nothing is more important than the health of you and your loved ones. Services must be up to scratch to

cater for everyone in West Oxfordshire – now and in future as this area develops. I have even raised both issues with Ministers and I will continue to fight hard to ensure that healthcare in this constituency is the best it can possibly be.

The first phase of the Sustainability and Transformation Plan consultation, which will determine the future of healthcare in Oxfordshire, is now live. I urge you to have your say on this crucial issue [here](#).

#### 4. Westminster

– The UK's withdrawal from the EU is was the subject of many debates in Parliament this week. I particularly raised the impact of leaving on the rural economy. Leaving the EU will give us a chance to rethink lots of legislation and see how we can better support and champion those issues which particularly affect rural communities. [More](#)
